The following conditions have to be met in order to maintain current Canadian qualification:

#### ----- Administrative Procedures

- 1) Sponsors applying for a TC Qualification based on the TC/FAA BASA SIP will comply with the following procedures.
  - a. Application for Continuing Qualification - The sponsor must request that the FSTD be continued under the provisions of the SIP and, prior to the expiry of the TC qualification, provide: A copy of the most recent FAA SOQ (Combined form T001 and T001A)
    - i) A copy of the most recent FAA FSTD evaluation report (form T002);
    - ii) The names of Canadian Air Operators requesting the use of the FSTD or used the FSTD in the last 12 months;
    - iii) The names of three Canadian airports included in the FSTD's visual database to support Canadian aircrew training and checking.
